Members considered the above application and were opposed to it on the grounds of noise and disturbance to neighbours.

12.00015.ful retrospective application for the erection of an agricultural building approved under application 10.00085 and erection of an additional agricultural/livestock building on land adjacent to Staynall Lane/New Road, Stalmine with Staynall, FY6 9DDT.

Members discussed this revised application and while noting the current application seeks to remedy the incorrect positioning of the present building (application 10.00085) Members were opposed to it. They thought the proposal overbearing and the currently underused building would be sufficient to support animal husbandry. The proposed building would detract from the visual amenity. Members thought the proposal would give rise to smells, adversely affect the manure management plan, and had the potential to pollute watercourses. Members also thought the proposal had not been given sufficient publicity.
