Report from the PACT meeting

PCSO John Holland reported on two crimes in the past month, an attempted theft from a vehicle on Joe Lane where the window was smashed but nothing was taken and a break in to a garage on Catterall Lane where tools were stolen. He added that the handling of the road closure by Catterall Gala members had gone smoothly at the weekend. There was still great concern that the Gala route will not be allowed on the A6 next year and clarification by the Police with regard to road closures and festivals was requested.

Catterall Village Hall Committee is appealing for a contribution towards the re-surfacing of the car park. To date no quotes have been obtained. Councillors considered that without figures the Parish Council is unable to progress this request.
