#### Location

Situated within ½ a mile of Junction 31A of the M6 Motorway, the M55, M61 and M65 Motorways are within easy reach providing access throughout the North West.

The Red Scar Business Park fronts Longridge Road (B6243) and forms part of the Preston East Employment Area.

#### Description

A detached concrete frame warehouse/industrial unit with a minimum eaves height of 6.15 metres, roller shutter goods door (3.6 metre wide by 4.6 metre high) with direct access on to a large servicing and car parking area.

#### Accommodation

The gross internal floor area extends to approximately 18,732 sq ft.

The unit has the benefit of offices and WC/kitchen facilities.

#### Services

All mains services are connected including gas, mains water, single and 3-phase electricity and mains drainage.

The warehouse area has the benefit of gas blown air heaters.

#### Assessment
