In the absence of the Chairman the Vice-Chairman took the meeting.

4570. APOLOGIES FOR ABSENCE

Apologies were received from Cllr. Mrs. E. Cookson and Cllr. E. Moorat. The reason for Cllr. E. Moorat's absence was accepted as he will be away for a number of meetings.

4571. NOTIFICATION OF INTERESTS

Councillors were asked to declare interests in the matters to be discussed and reminded that changes to their Register of Interests must be made within 28 days.

4572. MINUTES OF THE LAST MEETING

Resolved: The minutes of the meeting held on 6th December, 2017 having been circulated, were agreed and signed by the Chairman as a true record.

4573. PUBLIC PARTICIPATION

The meeting was suspended to allow residents to speak.

Including a Police Report:

October Anti-Social Behaviour – A family dispute was reported and a neighbour dispute.

November Crimes – Unknown offenders took lead from the roof of St John's Church, mud and branches had been fly tipped on a drive and a female reported being harassed by her former partner. Offenders made a failed attempt to remove the hitchlock from a horse trailer on Carr Lane causing damage to the A frame and a neighbour of an aggrieved had caused damage to a driveway whilst conducting agricultural work with a digger on Bradshaw Lane.

Anti-Social Behaviour – A resident reported a neighbour dispute, youths were reported smoking cannabis on Stakepool Drive and several residents reported flooding on Smallwood Hey and Lancaster Road and the behaviour of drivers making the situation worse.

December Crimes – A resident reported a malicious communication being circulated, a resident was assaulted in a domestic violence incident and an unknown offender scratched a vehicle parked on Lancaster Road, removing the wiper blades. A resident was assaulted during an altercation and unknown offenders broke into a shed on Garstang Road and stole fuel.

Anti-Social Behaviour – A resident reported concerns over the death of a pilot in fields near Fluke Hall Lane and a noisy party spilt out on to Garstang Road causing anti-social behaviour complaints.

It was noted that the present Sergeant at Garstang is to be replaced and thanks were expressed to Sergeant Freaney for her work under the limited resources it appears the police have to work with.

The meeting was resumed.

4574. PILLING IN BLOOM

Councillors discussed as to whether Pilling in Bloom is to continue and Cllr. W. Whiteside is to attend the meetings, write a planting design, select the plants and plant up. The first meeting this year is Wednesday 7 February, 7pm and Wednesday 9 May, 7pm in Committee Room 1, Civic Centre, Poulton. Volunteers are to be sought to weed and water the various displays throughout the village by Councillors.

Resolved: Pilling in Bloom will continue under the leadership of Cllr. W. Whiteside aided by volunteers

Resolved: Councillors accepted Bank Reconciliation and Financial Statement to 31st December, 2017.

Budget 2018 – 2019 and Precept 2018 – 2019

The budget was presented to Councillors with suggested precept calculations. It was raised that future essential services are envisaged to be dropped by principal authorities and therefore Parish Councils may be needed to supply them. A vote was taken and the majority resolved to increase the precept by £2,000.

Resolved: That Pilling Parish Council will set the precept at £56,000 and inform Wyre Council.

4578. VERBAL REPORTS FOR INFORMATION ONLY**Report of the representative on the Pilling Memorial Hall Committee/Pilling 20:20**

Cllr. P. McWhirter reported the Committee has acknowledged receipt of the Lottery offer and are working towards appointing an architect and professional design team with the advance of £48,000. Funds from other sources to make up the shortfall have been submitted and funding for a changing room also submitted. The weather has been against the completion of the trim trail and there are numerous trees to plant in the next few months. The Chairman mentioned the invaluable assistance from Rosie Green at Wyre for submissions and the continued support from Garry Payne, the Chief Executive.

Senior Citizens' Christmas Party

The Chairman thanked everyone who helped at the party and thank you cards were read out. A donation was received during the Senior Citizens' Christmas Party and this will be used towards next year's party.

Halite Community Panel

Cllr. Mrs. D. Schofield reported on the road to be laid between Knott End and Nateby to join to the main gas pipeline. The panel members are insisting that reports of the work are kept updated.

Flooding on School Lane and Damside

The Parish Lengthsman has investigated the flooding in gardens on School Lane and reported it to the School House management for action.

Flooding on Damside was partly caused as water could not get away as the Broadfleet was so high. On 3rd January the Environment Agency was informed water was travelling upstream into Pilling Water, but a message from the Environment Agency the

day after said everything was working fine and it was the size of the tide causing problems.

Flood Action Group

Next month John Blundell, Wyre Council will be attending to discuss the setting up of a Flood Action Group in Pilling and residents who are interested will be most welcome to attend and sign up.

Santa Claus

The suit Father Christmas used for the Christmas Tree switch-on is from Pilling and this has been privately purchased and donated to the Parish Council to keep safe.
